PENNSYLVANIA STATE CHAPTER, N.W.T.F. REGULAR MEETING KEATING SPORTSMEN'S CLUB McKEAN COUNTY NOVEMBER 8 and 9, 1985

The November 1985 board meeting of the Pennsylvania State Chapter was called to order by President Dan Roessner at 7:30 p.m. on Friday, November 8, 1985.

Dan Roessner reported that he helped man the booth the Allegheny Sultans had at the Warren Mall, Warren, Pa on National Hunting & Fishing Day, he attended a day at Turkey Mountain Lodge where the National Board of Directors were holding their meeting. Dan said he met with Mr. Russ Hill, relative to the Land Use Plan for the Allegheny National Forest. Dan said he had helped the committees of Turkey Talk, and also on the Art, Stamp Print committee.

FIRST VICE PRESIDENT'S REPORT

SECOND VICE PRESIDENT'S REPORT

Howard Meyers gave the report for Tom Baldrige who could not attend this meeting. In Tom's report he said he wanted to send in all portfolio's to National by December 27th, Tom said that it looks like we won't win the award this year since not to many people have sent in information from the chapters and also what each director has done for the State Chapter. The group felt we must all help out with the information Tom needs to do his job.

COMMITTEE REPORTS

The new editor of Turkey Talk, Dan Sullivan received a round of applause from the board for his work in his first issue. Dan did a great job. Dan said that he had asked Jerry Wunz, Pa. Game Commission to contribute some articles for future issues of Turkey Talk. Dan said the issue was out on time and that we had 300.00 of advertising in this issue. Dan said he feels our ad prices our to low and he and his committee will work on this problem. Dan said some of his ideas, are a Local Chapter column, a survey from the membership on "What they want in Turkey Talk". Dan reported the budget for Turkey Talk will 11,000 for 1986, he said he will cut cost where he can. This last issue of T.T. 6,000 copys were printed up. Dan said he would for go any payment as Editor for a while.

YOUTH

A letter of resignation from Patrick Sullivan was read, Pat regrets being unable to continue on this committee but his time is very limited now.

HABITAT

Tim Holtz reported that the committee will meet to review habitat proposals from the department of Forestry, a further report will be given at the next board meeting.

PUBLIC RELATIONS CHAIRMAN

Chairman Richard Weaver gave out a printed report. Highlights of Dick's report were he had contacted the Pennsylvania Game Commission about meeting with them to talk over problem areas, Rich said a meeting maybe forcomming in December, 1985. Rich also passed out paper copies of a poster that was drawn up for the Landowner project in a new landowner cooperative that may get some land opened for the spring season. Rich also checked on the public service spots offered by Austin-Nichols. Rich helped man a booth for National Hunting & Fishing Day.

NWTF

President Dan Roessner reported that the National Wild Turkey Federation would like six local chapters to sponsor banquets for the N.W.T.F. this year in Pennsylvania. Dan said funds from these banquets could be as much as 20,000 back to the Pennsylvania State Chapter for Habitat.

LEGISLATIVE

Chairman Norm Schlosser reported on the Endangered Species Act, also that the Pa Game Commission officers are now on a fourty hour work week, with no overtime being given at this time. Norm gave a Toll Free number to report any type of pollution problem, or violation - 800-854-7365. The Pennsylvania Coalition is interested in having the Pennsylvania State Chapter join the coalition, after a brief discussion about the fee of 100.00 for membership, A motion was made by Dan Sullivan to authorize the Legislative committee to take a membership in the Pennsylvania Coalition, seconded by Norm Schlosser. Motion carried. If we are accepted as a member by the Coalition, Norm Schlosser and Richard Weaver will be our delegates. Norm reported the Pa. Game Commission is trying to combine both the Hunter Education classes and the Trapping classes. The legislative committee feels this should be opposed because each course should remain seperate to be covered properly. A motion by Jack Crouse to have the legislative committee submit a letter to the Pa. Game Commission opposing this proposed new course of action, seconded by Bob Nodler. Motion carried. Norm reported on the recodification of the states Game laws, he also noted that a move is being made to reduce the price of the senior life-time license. Some important bills to support are SB-45, Homeowners Protection Act. HR-945 House - this bill is very important and needs our support, this bill will overturn the 1968 gun law.

BUDGET

Tim Holtz gave out the budget report, he requests comments on any topic in the budget at the January meeting.

1986 CONVENTION

Howard Meyers reported that the Gun raffle tickets should be out in November. a double mailing is being planned for this years raffle. Howard read a "Whats New for The 1986 Convention" Some important items to note is the Annual business meeting is to be held at 8:15 a.m.- a Ladies seminar is being planned and a Sportsmen's Raffle similar to the Ducks Unlimited banquets is being planned for the banquet this year. We hope to have three guns included in the Sportsmens raffle. Tickets will go on sale at 6:00 p.m. Other things new for the banquet will be a write-in auction, a chinese raffle, and ladies door prizes. Stu Harshberger reported that all the judges have been chosen for the calling contest and a run off contest if needed will begin at 1:00 p.m. on friday. Stu said the master of ceremonies for the contest will be Bob Clark. Stu then passed out posters announcing the convention (see example in the minutes) if any local chapter would like some posters contact Stu Harshberger as soon as possible. Stu also reported the passing of John Ostrosky president of the Laurel Run Highlands Local Chapter, a moment of silence was observed. C

PA GAME COMMISSION

Jerry Wunz thanked the members of some of the local chapters in the northwest region. These chapters helped out in a brood census in Erie, Crawford, and Mercer countys. Jerry said the game commission is going to try and simplfy the brood census form for next year.

REWARD

A reward payment was requested but a problem developed and President Dan Roessner was to check with the game protector on this question. Action was tabled on this reward request till the January 1986 meeting.

After these reports the friday night meeting was recessed at 12:45 a.m.

The meeting was reconvened at 1:16 p.m. on Saturday, November 9, 1985, with President Dan Roessner calling the meeting to order. It was determined that a quorum was present and that the business of the State Chapter could be conducted.

PA GAME COMMISSION

Jerry Wunz continued his report, Jerry said the trap & tranfer program for the state is completed but that trap & tranfer of wild turkeys will still go on in each game commission region. Jerry said turkeys will be trapped and released in the same region, to replentish birds that may have failed to get started in that region. Jerry said the lack of small game is causing more hunters to turn to turkey hunting. Jerry reported on the new turkey management areas from three to eight areas. Jerry said all areas stayed as the game commission had proposed but one, he said a local chapter had sent letters to the game commission to change the boundries between turkey management area two and three. Jerry finished his report and left for his home. A discussion about this local chapter had acted on their own and had not made any contact with the state chapter on the matter. After a brief discussion, Fred Webster, head director of the Northwest Region, was asked to contact the chapter and director involved in this matter and report back at the January meeting.

READING OF COMMUNICATIONS

A letter was read from the N.W.T.F. appealing for more funds for the radio telemetry equipment.

OLD BUSINESS

Information on the Past Presidents pin passed on by Lou Mamone was given at this time. <u>A motion to table action on the pin at this time was made by Ron Sandrus</u>, seconded by Jack Crouse. Motion carried.

President Dan Roessner would like to have a full slate of officers and directors for the 1986 year. At the present time the position as First Vice President is open, Dan would like to know of candidates for the position of Secretary.

ART PRINT AND STAMP COMMITTEE

Terry Hyde reported on the Toschick orginal and the Dan Feaser orginal painting, Mrs. Feaser is in need of funds she suggested a raffle drawing similar to the Ned Smith orginal, Terry presented a plan to the board to have raffle tickets printed up for both the Toschick orginal and the Feaser orginal, this way members could buy what ever ticket they want for either painting. One-half of the profit after expenses would go to Mrs. Feaser for the Feaser painting, one-half of the profit after expenses would go to Larry Toschick for his painting. Terry would have a booth at the convention to sell the tickets and raffle tickets would be mailed to our members. The raffle would take place in the spring. <u>A motion to conduct the raffle as arranged by Terry Hyde and the Art Committee was made by Dan Sullivan, seconded by Ron Sandrus. Motion carried. Nay votes were cast by Jack Crouse and Bill Barron. Terry reported the Conservation print by artist Jack Palut will be ready by the spring season. The contract is being drawn up, the state chapter will be sole owner of the orginal painting. Turkey Talk will feature a color cover for the April issue of the Conservation print, prints will cost 50.00 each. A request was received from Lou Hoffman, Editor of the Pennsylvania Sportsmen.</u>

NEW BUSINESS

The turkey safety points booklet is being reprinted. The State Chapter will order 5,000 copies as soon as we have the funds to pay for them.

The Keating Sportsmen have a raffle ticket for winter feeding. Interested people please take one. The Keating Sportsmen have also asked to come back at some later date to hold another meeting.

There being no further business to come before the assembly, <u>a motion to</u> adjourn was made by Steve Lecorchick, seconded by Terry Hyde. Motion carried.

The Pennsylvania State Chapter had an order of paper supplies come early in 1985. Officers and Directors were asked to take some home with them for their use. 



The August 1985 board meeting of the Pennsylvania State Chapter was called to order by President Dan Roessner at 7:05 p.m. on Friday, August 8, 1985.

Dan Roessner welcomed everyone to the meeting, and extended a special thanks to Jim Leach and several members of the Susquehanna Local Chapter for hosting and funding the meeting.

It was then stated that a quorum was present and that the State Chapter could conduct the business to come before it.

PRESIDENT'S REPORT

Dan Roessner reported that he was the Master of Ceremonies at a Turkey Calling Contest held by the Allegheny Sultans Local Chapter at Titusville, Pa. On July 26 & 27, he attended the Northwest Regional meeting at Trout Run on behalf of the State Chapter. Dan also is helping on the <u>Turkey Talk</u> Committee. Dan said he had received three resignations which he read. Resignation as Editor of <u>Turkey Talk</u>, Bud Erich, resignation as Assistant Editor of <u>Turkey</u> <u>Talk</u>, Gary Eckert and resignation as southeast Head Director, Steve Rheaume. Dan than read a list of new appointments that he was making after a meeting of the Executive Board. Bud Erich is appointed new Assistant Editor of <u>Turkey</u> <u>Talk</u>, Jim Roessner is appointed new Advertising Manager, <u>Turkey Talk</u>, Dan said he would talk to Dennis Strawbridge and see if he would accept the position as Southeast Head Director.

FIRST VICE PRESIDENT'S REPORT

SECOND VICE PRESIDENT'S REPORT

Tom Baldrige reported that he has been receiving portfolio material and he would like to receive more from each Local Chapter before the December 15th deadline. Tom reported on a problem on section 29 of the portfolio for 1984. Carl Brown, NWTF had told Tom that section 29 of the portfolio should receive up to 200 points for each item in section 29. Any motion or second to a motion must be made by a board member or director. <u>A motion to ap-</u> prove the minutes of the June Regular meeting 1985, was made by Steve Lecorchick, seconded by Norm Schlosser. Motion carried.

TREASURER'S REPORT

Tim Holtz presented the balance sheet comparative statement. The fund balance as of 8-9-85 was 4106.99. Tim said he would be handing out the budget request forms at this meeting and asked to have them returned promptly. <u>A motion</u> to approve the treasurer's report as presented was made by Fred Webster, seconded by Bill Barron. Motion carried.

MEMBERSHIP SECRETARY'S REPORT

A brief report was sent by Don Heckman in his report it was noted that the renewal rate for membership is at the 76% level. Don reported that we are experiencing a slow growth rate and that their are now 28,800 members in the National Wild Turkey Federation at the present time.

CHAIRMAN OF THE BOARD REPORT

Ron Sandrus said he was going to update the Local Chapter list. Ron also said things looked good for a Local Chapter in the Mansfield area. Ron said he attended the Allegheny Sultans turkey calling contest and the Northwest Regional meeting at Trout Run.

VICE TREASURER'S REPORT

No report.

TURKEY TALK

New editor Dan Sullivan read a list of the new <u>Turkey Talk</u> Committee. Dan Sullivan, Chairman, Bud Erich, Co-Chairman, Jim Roessner, Advertising Manager, Richard Weaver, Legislative consultant, Don Heckman, Labels, Ron Sandrus, Consultant and Shirley Grenoble, Material. Dan said we must budget 10,000 per year to operate and produce <u>Turkey Talk</u>. Dan feels that printing costs are reasonable at Nupp Printing Company. Dan wants to have <u>Turkey Talk</u> out by October 15, 1985, articles and material for the January 1986 issue must be in by November 15, 1985.

TURKEY TALK ADVERTISING

Jim Roessner, the new advertising manager was introduced and greeted by the board. Jim said he had some advertising requests and sent out some information to future advertisers.

HABITAT COMMITTEE

No report.

PUBLIC RELATIONS CHAIRMAN

Richard Weaver was asked to check on advertising in Turkey Call, Rich asked Local Chapter Presidents to contact him if they can help in public relations in their local area.. Rich also needs help from the Local Chapters in knowing area newspapers and outdoor writers who print articles on hunting and the outdoors.

LEGISLATIVE COMMITTEE

Norm Schlosser, the new chairman would like to have new members on his committee. Norm asked for support on SB-80, this bill would raise fines on killing a wild turkey out of season from fifty dollars to 125.00. Norm reported that HB-585 was passed without any admendments attached. Norm also reported that the recodification of the State Game Laws was almost completed. The Game Commission wants to make the wild turkey a BIG GAME BIRD, the question came up this change could require a turkey hunter to wear fluorescent orange will hunting wild turkeys. Norm stated that various meetings on the recodification of the game laws would take place in different locations throughout the state, these meetings would take place before our November board meeting. Norm asked the State Chapters position about wearing fluorescent orange will turkey hunting? After a lengthly discussion; A motion was made by Tom Baldrige, that the PENNSYLVANIA STATE CHAPTER DID NOT support the mandatory wearing of fluorescent orange to hunt wild turkeys, but the PENNSYLVANIA STATE CHAPTER DOES support the mandatory training of new hunters in the aspects of Safe Turkey Hunting. Seconded by Steve Lecorchick. Motion carried. Norm reported that a Pennsylvania Coalition is forming and that Dick Weaver would attend a meeting and report back at the November meeting. Norm gave a report on the two different plans for the Allegheny National Forest, Plan B and Plan D. Norm read a letter sent by the James E. Wilhelm Memorial Local Chapter to support Plan B.... A motion was made by Norm Schlosser to make this letters content the stand for the Pennsylvania State Chapter on this long range plan for the Allegheny National Forest. Seconded by Dan Sullivan. Motion carried, with one abstaining member.

1986 CONVENTION

Howard said the exhibits will be open during the Masters calling contest this year with certain restrictions; also the Annual membership meeting will be moved from 4:00 p.m. to 8:15 a.m. on Saturday. Those who attend the meeting will have available to them a continental breakfast free of charge. This move should be helpful for the art auction, Tom mentioned that we will have two seminars for ladies this year, the seminars will be on make-up and antiques.

LOCAL CHAPTER PRESIDENT'S REPORT

After these reports the friday night meeting was recessed at 1:03 a.m.

The meeting was reconvened at 9:00 a.m. on Saturday, August 9, 1985, with President Dan Roessner calling the meeting to order. It was determined that a quorum was present and that the business of the State Chapter could be conducted.

GUEST SPEAKER

President Dan Roessner introduced Frank Rice to the board. Frank had attended the NWTF Wild Turkey Symposium at Des Moine, Iowa, and had given a report on the National Wild Turkey Federation's Strip Mine Project in Pa. Frank thanked the State Chapter with helping him make the trip, Frank then gave a talk on his strip mine project. It was noted that a lot of new people had come on the board who had never heard of Franks project which took place in 1981 in Centre and Clinton Counties. This project took place on State Game Lands 100 an unstripped area and on stripped areas that adjoin State Game Lands 100. It was the concensus of this project that it is very important to get strip miners to replant the stripped area with trees and shrubs along with the grasses now being planted on these areas. Frank urged the Local Chapters to contact landowners whose land was going to be stripped to inform these landowners that they can tell the strip miners what they want planted on their lands. Franks report showed that wild turkey really like the 30 to 40 year old strip mines and a lot of this prime habitat is being restripped now and is being replanted in grasses only.

NWTF WILD TURKEY SYMPOSIUM

Dale Jeffrey gave an overview of the Iowa Wild Turkey Symposium. Dale said 27 reports ranging from the effect of illegal turkey kills (scheduling of seasons); problems with farm raised turkeys released in the wild, were given at the week long symposium. Dale said as a spectator to this symposium he learned much more about the wild turkey here in Pennsylvania and all over the United States

ART PRINT AND STAMP COMMITTEE

Terry Hyde reported on our print program, he said most programs outside of the National Wild Turkey Federations program are having problems. Terry said the market is very soft and other states are also having the same problems that we are having selling art prints. Terry reported that we now have \$4,100 in the stamp print program, Terry also said that artist Larry Toschick still has not been paid and that he is still trying to work out an agreement over the money owed to Toschick. Terry said he would like to see the State Chapter start a State Chapter Conservation Print of which the State Chapter would have 100% control. After Terrys report a discussion followed on how to clear up the debt to artist Larry Toschick; this led to <u>A motion by Jack Crouse to clear up this</u> <u>debt in one of three manners</u>.

Return the orginal painting to Larry Toschick and wipe the slate clean.
 Sell the orginal painting - split the profit 50-50 with artist Toschick.
 Pay Larry Toschick the money owed to him outright.

the motion was seconded by Norm Schlosser. Motion carried. Shirley Grenoble then made <u>A motion to authorize the Art Print Committee</u>, through recommendation of the Executive Board to proceed with the Conservation Print Program upon the finalization of the Toschick problem, seconded by Reed Johnson. Motion carried.

ANNOUNCEMENT

President Dan Roessner said that during the lunch break a meeting of the Executive Committee took place and Dan was making the following appointments. Larry Utnik is being appointed a Director in the Soutwest Region and Dale Jeffery is appointed to the Vice Treasure's position.

OLD BUSINESS

Dave Fisher posed a question to the board at this time, Daves question, "Why doesn't the Local Chapter Presidents have a voting voice at the State Board meetings?" This question was discussed thoroughly by the board with no clear answer to this question at this time.

ROGER LATHAM TURKEY SERVICE AWARD NOMINATION

Nominations were ask from the floor for a nominee for the Roger Latham Turkey Service Award. Fred Webster nominated Ron Fretts, seconded by Terry Hyde. Ron Sandrus nominated Gary West, seconded by Jack Crouse. Tom Baldrige nominated Howard Meyers, seconded by Joe Krug. Howard Meyers declined the nomination. Motion to close nominations by Terry Hyde, seconded by Jack Crouse. A vote was taken by secret ballot for the nomination of either Ron Fretts or Gary West for the Roger Latham Turkey Service Award. Results of the voting are as follows: Ron Fretts - 16 votes, Gary West - 5 votes, Shirley Grenoble requested that her vote be recorded as a no vote for Ron Fretts. Ron Fretts will be the nominee for the Roger Latham Turkey Service Award from the Pennsylvania State Chapter.

NEW BUSINESS

Tom Baldrige made <u>A motion to nominate both Ron Fretts and Jan Bausinger</u> to the National Wild Turkey Federation's Board of Directors pending their situations, seconded by Fred Webster. Motion carried.

Howard Meyers reported on the tentative meeting places for 1986. The January meeting will be in Huntingdon County, tentative date for the meeting will be fri. 17th and saturday 18th, March, Monroeville, June, Somerset County, August, Blue Mountain Local Chapter will host this meeting at the French Creek State Park, Berks County and the November meeting will be hosted by the new Wilson F. Moore Memorial Local Chapter in Susquehanna County. Howard asked the other local chapters to follow the lead of the Roger Latham and the Susquehanna local chapters to host and fund a State Board meeting. We need to start working on finding meeting locations for 1987.

There being no further business to come before the assembly, a motion to adjoun the meeting was made by Tom Baldrige, seconded by Norm Schlosser. Motion carried.

The meeting was adjourned at 3;30 p.m.

House Bill 180g - anti-trapping Bill NOTE - The state of New Jersey passed an anti-trapping Bill - No trapping is permitted in New Jersey. Write to your congressmen and inform him that you don't want HB 1809 passed. Dan informed the board of plans to change management of the Allegheny National Forest, two plans B. and D. were being considered. Dan recommended we support plan B., to keep management of the

forest consistant with good wildlife management. <u>A motion was made to support plan B. by Steve</u> <u>Lecorchick, seconded by Jack Crouse</u>. Letter in support of plan B. will be sent by the legislative committee. House Bill 632 - and 970 Saloom admendments must be defeated. Dan Sullivan said HB 585 with the admendments tacked on in the House can't be passed with the admendments. FIRST VICE-PRESIDENT'S REPORT - Terry Hyde indicated that the NRA Turkey Hunting Clinic which was originally planned for April, 1985 has been postponed to April, 1986. This clinic, co-sponsored with the NWTF, is planned for the Philadelphia area.

MEMBERSHIP SECRETARY'S REPORT - Don Heckman reviewed membership totals for the 1983-1984 year, and indicated that the membership level as of December, 1984 was 4,990 members. He also reviewed the rebates received from NWTF during 1984 which totalled \$10,324.00.

Don also stated that new local chapters in an existing local chapter area should review their zip code directory with other local chapters in a designated area to be sure that duplication does not occur. New local chapters must submit a zip code directory to the Membership Secretary for verification and submission to the Membership Director at NWTF.

Membership levels reports for all local chapters within the State Chapter organization are available for each month of the calendar year. These reports are available at each State Chapter Board of Director's meeting, and show current renewal members and new members and their addresses.

TURKEY TALK COMMITTEE - Dan Roessner reported that he had talked to Bud Erich recently and that Bud had indicated that the current edition of Turkey Talk was at the printer's office and would be mailed within the next few weeks. Bud also noted that the deadline for articles to be included in the spring edition was February 15, 1985, and that if all went well, the Spring edition would be out by mid-April.

Ron Sandrus indicated that since we did not have a contract with Nupp Printing to consider, he had asked Dan Sullivan to attempt to secure a contract for consideration at the general membership meeting at the State Convention in March, 1985.

<u>ADVERTISING COMMMITTEE</u> - Ron Sandrus said that he had received several adverse comments from advertisers in Turkey Talk due to the late publication of issues of Turkey Talk. He noted that he would like to have this matter brought up under old business for general discussion on Saturday.

PROMOTIONAL ITEMS - It was reported that Ron Hudsick had no promo items available, and that Howard Meyers should be asked what can be done to secure more of the needed items.

YOUTH COMMITTEE - Terry Hyde and Dick Weaver reported briefly on the possibility of a "regional" JAKES seminar, and that this committee would make further recommendations on this matter in the future.

ART PRINT & STAMP COMMITTEE - Terry Hyde reported that due to the death of artist Dan Feaser, the 1983 Stamp Print artist's proofs were not completely signed, leaving approximately 25 unsigned artist's proofs. He also reported that due to the poor sales of the 1982 and 1983 Stamp Prints, it appeared likely that there would be no 1984 Stamp Print Program.

STAMP PRINT PUBLICITY No report given.

HABITAT COMMITTEE - No report given

PUBLIC RELATIONS CHAIRMAN' REPORT - No report given.

NATIONAL REPORT - No report given.

STAMP PRINT FINANCE COMMITTEE - Terry Hyde reported that there had been no sales of stamp prints during the last quarter of 1984, so that the ending balance of \$1,085.18 was the same as at the beginning of the quarter.

He then stated that the State Chapter is participating with NWTF in the promotion and sales of stamps, and that NWTF will return \$1.00 to the State Chapter for each stamp sold during this promotion.

<u>1985 STATE CONVENTION</u> - Don Heckman gave an in-depth report on the plans for the 10th Anniversary Convention, including a detailed listing of all committee assignments and responsibilities. He noted that plans were progressing quite well, and expected the 1985 Convention to be a financial success.

CONSERVANCY COMMITTEE - No report given.

NOMINATING COMMITTEE - Bob Nodler gave a report on the findings and recommendations of the Nominating Committee. He stated that vacancies existed for the offices of Vice-Treasurer, Advertising Manager of Turkey Talk, and Director in the Southwest, Southcentral, and Northeast Regions of the State. He added that the nominations letter to the general membership would be mailed in the near future.

AWARDS COMMITTEE - Dick Weaver gave a brief report on the nominations received by the Awards Committee for the various service awards to be given at the 1985 Convention.

HEAD DIRECTORS REPORTS - The following reports were presented:

North West Region - Dan Roessner South East Region - Steve Rheaume

LOCAL CHAPTER REPORTS - The following chapters were represented at the meeting and each gave a brief description of their past and planned activities:

The meeting was recessed at 10:47 P.M.

The meeting was re-convened at 10:00 A.M. on Saturday, January 26, 1985, with President Ron Sandrus calling the meeting to order. It was determined that a quorum had been established and that the business of the State Chapter could be conducted.

Ron Sandrus announced that at an Executive Committee meeting held on Friday evening, the following were appointed to a Director position within their respective regions:

Skip Schaich - SE Tom Szerlik - SE Dale Miller - NW Ralph Holtin - SC

<u>SECOND VICE-PRESIDENT'S REPORT</u> - Howard Meyers thanked all local chapters who had submitted portfolio materials to him, and said that these materials aided him in the preparation of a first-class portfolio. Howard also reviewed the point totals with the group, and said that he felt the State Chapter should score quite high in the Outstanding Chapter competition.

SECRETARY'S REPORT - Under amendments to the minutes, it was noted that reference to total expenditures for the nine-month period should be changed to read "for the three-month period". <u>A motion to approve</u> the minutes of the November 9, 1984 meeting, as amended, was made by Tom Baldrige, and seconded by Fred Webster. Motion carried.

TREASURER'S REPORT - Tim Holtz presented the Treasurer's Report for the period 1/1/85 - 1/24/85, indicating income of \$2,640.77 and expenses of \$1,918.64, leaving a current fund balance of \$2,084.09. A motion to approve the Treasurer's Report as presented was made by Tom Baldrige, and seconded by Lou Mamone. Motion carried.

Membership Secretary Don Heckman pointed out that there are approximately 2,000 NWTF members throughout the State that are not currently assigned to a local chapter. Any chapter wishing to add some of these members to their local chapter should contact Don Heckman.

<u>OLD BUSINESS</u> - Ron Sandrus noted that prior to the printing of new habitat pamphlets, the habitat committee would review the pamphlet and make necessary changes and corrections.

Lou Mamone presented several ideas concerning the design of a Past President's Pin, and gave several cost figures for the group to consider. After much discussion on the matter, <u>a motion to refer the matter back to the committee and ask for a further report at the March, 1985 meeting was made by</u> Don heckman, and seconded by Terry Hyde. <u>Motion carried</u>.

Howard Meyers gave a presentation on the status of the order for certain promotional items such as decals, pins, hats, t-shirts, and pencils, and said that he was working with A to Z Advertising relative to the placement of an order. He added that funds for promotional items were extremely limited, but that he would work with Tim Holtz in order to determine other sources of funding for the purchase of these items.

Dave Fisher handed out copies of a proposal which requested funding for a habitat improvement project in Fayette County, which was then referred to the Habitat Committee for review and recommendations.

Dan Roessner spoke about the progress being made on the production of the 10th Anniversary Commemorative Knife, and indicated that the Board had already given its approval to an order of 100 knives each of the field grade and presentation grade. Since it had been suggested that the first 50 knives of each edition be reserved for the holders of the corresponding number of the Pennsylvania State Stamp Print Series, a motion to increase the knife order by 50 knives of each series, bringing the total order to 150 knives of each series was made by Tom Baldrige, and seconded by Howard Meyers. Motion carried. After a discussion on the projected costs of these knives to the State Chapter, a motion to set the price of the field grade knife at \$25 and the presentation grade knife at \$40 was made by Terry Hyde, and seconded by Lou Mamone. Motion carried.

Tim Holtz reported briefly on the activities of the Habitat Committee, and noted that the Board had approved the amount of \$5,000 for habitat improvement projects in 1985 which would be undertaken with the cooperation of the Pennsylvania Department of Environmental Resources. He said that he would contact Gary West concerning the actual projects to be undertaken, as well as present Dave Fishers' request for funding consideration, and hoped to have the Committee's recommendations ready by the March, 1985 meeting.

A discussion then followed concerning the displeasure voiced by certain advertisers in Turkey Talk relative to the late publication of the newsletter. It was suggested that in order to avoid this situation in the future, it might be possible to drop all advertising from Turkey Talk for a period of time, or to consider dropping the advertising altogether. The pros and cons of the situation were discussed at length, as well as what could be done to insure that future editions of Turkey Talk were issued on schedule. After further discussion, a motion directing Ron Sandrus to talk to Bud Erich concerning his intentions as Editor of Turkey Talk and his willingness to continue in that capacity was made by Howard Meyers, and seconded by Bob Nodler. Motion carried.

Bob Clark made several suggestions relative to the Hall of Fame Awards which are presented annually at the State Convention, and it was noted that these suggestions would be taken into consideration by the Awards Committee.

In the absence of Legislative Committee Chairman Dan Sullivan, Dan Roessner reported on House Bill 388 which would ban the sale, possession, and use of the foothold trap in Pennsylvania, and that the Committee was opposed to the passage of this bill. After further discussion, <u>a motion authorizing</u> the Legislative Committee to draft a resolution stating the State Chapter's opposition to this bill was made by Shirley Grenoble, and seconded by Don Heckman. Motion carried. The Legislative Committee was also given a consensus of approval to send a letter to the Pennsylvania Game Commission voicing the State Chapter's support of proposed hunting license increases, as well as a letter congratulating the PGC for their work in connection with the arrests relative to black market wildlife sales.

Don Heckman requested that a written final report from each of the Convention committees be sent to him by March 6, 1985.

Howard Meyers reminded everyone of the habitat improvement work session to be held in Fayette County on April 21, 1984, which also involved the West Penn Power Company, the Pennsylvania Game Commission, and the Ruffed Grouse Society. Further details of the work session can be obtained by contacting Howard Meyers.

Don Heckman spoke about the possibility of preparing new Director's packets which would be given to all Directors of the State Chapter and would outline the duties and responsibilities of the Director position. Howard Meyers indicated that he would contact Jack Crouse relative to this matter, and report further at the March, 1985 meeting.

Tim Holtz presented the proposed operating budget for the 1985 year which projected operating income of \$39,115 and operating expenses of \$38,115, leaving a figure of \$1,100 income after expenses. A brief discussion was held on various line items within the budget. <u>A motion to adopt the 1985 Operating</u> Budget as presented was made by Dan Roessner, and seconded by Tom Baldrige. <u>Motion carried</u>. Ron Sandrus expressed the State Chapter's appreciation to Tim Holtz and his Budget Committee for the fine job they had done in the preparation of the operating budget.

Ron Sandrus spoke concerning a letter he had received from NWTF requesting donations which would be used for the purchase of telemetry equipment to be utilized by wildlife biologists throughout the country. After further discussion, a motion to donate \$500 to NWTF for the purchase of telemetry equipment was made by Steve Lecorchick, and seconded by Shirley Grenoble. Motion carried. 10 ayes, 3 nays.

Don Heckman noted that there had been no representation from NWTF for the last several meetings, and asked what could be done to insure that the State Chapter receives a report concerning what is happening at NWTF. Ron Sandrus said that efforts would continue to encourage the attendance at State Chapter meetings by Pennsylvania's representatives on the NWTF Board. Dan Roessner stated that he would send a written request to NWTF asking that copies of NWTF Board Meeting minutes be sent to the State Chapter President and Secretary. Tom Baldrige spoke about the submission of the State and local chapters portfolios to NWTF for judging in the Outstanding Chapter competition each year, and suggested that the submission of each local chapter's portfolio to the person responsible for the preparation of the State Chapter's portfolio would insure that local chapter activities could be included in the State Chapter's portfolio. <u>A motion requiring</u> each local chapter to submit their portfolio directly to the Second Vice-President of the State Chapter, which in turn would be forwarded to NWTF for judging, was made by Tom Baldrige, and seconded by Fred Webster. Motion carried.

There being no further business to come before the assembly, <u>a motion to adjourn the meeting was made</u> by Fred Webster, and seconded by Dennis Strawbridge. Motion caried.

The meeting was adjourned at 3:13 P.M.
