## Harvest Management

The preliminary 2006 fall turkey harvest was 21,500 (see table). That compares with 23,321 in 2005; 25,868 in 2004; and 27,400 in 2003. Fall harvests haven't been as substantial as spring harvests, partly by management design (shorter seasons) and largely because fewer people are hunting in the fall. In 2005 – the latest year for which data is available – turkey hunters recorded more hunter-days afield in the spring, about 1,038,000 than in the fall about 685,000. The number of turkey hunters afield in the spring was about 20 percent higher than in the fall, which has seen a slide in participation over the past decade.

Harvest report cards received to May 30, 2007 for the spring 2007 turkey season are 7% below the previous 3-year average for the same time period. We continue to receive report cards until the 4<sup>th</sup> Wednesday after the close of the season (June 20<sup>th</sup> this year), at which time we will make our final count. The harvest began somewhat slowly, and has rebounded during the second half of the season, possibly due to the cold weather during mid-April which may have delayed some nesting. Half-way through the season report cards were 16% below the previous 3-year average.

There were 7,582 Special Spring Turkey Licenses sold compared to 8,041 in 2006. As of May  $30^{\text{th}}$  we received 1,079 reports from special licenses (491 kills, 138 no kills, 450 to be entered), compared to only 400 reports (all kills) last year. The mandatory reporting is beginning to catch on.

## Wild Turkey Management Plan Revision

Submitted an article regarding the revised wild turkey management plan to PA Turkey Talk Newsletter for the summer issue. Bob Eriksen and I completed the Turkey Frequently Asked Questions (FAQ's) section for the PGC website and submitted the package to the Bureau of I & E, as per management plan Information and Education Objective strategy 3.4. The 94 questions are arranged into 10 different sections ranging from turkey biology to turkey hunting to turkey oddities.

## Wild Turkey Spring Harvest Rates and Annual Survival Rates Study

Turkey trapping and leg banding concluded at the end of March for this winter as part of this study, with 995 gobblers banded across the 3 states (NY - 382, PA - 334, OH - 279).

There are two more winters of leg banding. The Cooperative Fish and Wildlife Research Unit at Penn State maintains the toll-free number for reporting for leg band returns.

As of May 23<sup>rd</sup>, 108 leg-banded gobblers have been reported within PA, 8 of which were found dead (5 banded in 2006 and 3 banded in 2007) and 100 were harvested. Fifty-four of the 108 were reward band birds. Of the harvested birds, 30 were banded in 2006 and 70 were banded in 2007. Of the reward-banded turkeys, 37 were banded this year and 17 were banded in 2006. Distance traveled from banding to harvest location will be analyzed. Thus far we know of 3 turkeys banded as jakes in 2006 traveled about 10 miles from the capture location. Conversely, one turkey banded as a jake in 2006 traveled on 1.5 miles from the capture location.

In Ohio, 103 leg-banded gobblers have been reported, two of which were found dead and the other 101 were harvested, 59 of which were reward-banded turkeys. Ohio researchers attached transmitters to 70 gobblers this winter, 24 of which were harvested and one additional transmitted gobbler was found dead. Eighteen of the 101 harvested gobblers were banded in 2006.

In NY, 105 leg-banded gobblers have been reported, 8 of which were found dead and 97 were harvested. Thirty-four of the harvested gobblers were banded in 2006 and 63 were banded this year. Forty-nine of the 105 were reward-banded turkeys.

## Micheaux State Forest Summer Sighting Surveys

Thanks to a well-established cooperative effort among the PGC, DCNR, Bureau of Forestry (BOF), and volunteers from the National Wild Turkey Federation, the tenth year of weekly Summer Sighting Surveys on the Michaux State Forest will be conducted to provide an additional index to turkey population trends besides our harvest and hunting success trend date for WMU 5A. This is the area of the turkey radio-telemetry study were we investigated the causes of the suppressed wild turkey population and closed the fall season in 2003 to aid in population recovery. Six routes (approximately 30 miles each) are conducted from June through August. Additionally, since 2002, Bureau of Forestry staff record on a daily basis, all turkeys they see and miles driven, to get an index of turkeys seen per mile driven and productivity (poults/hen), as additionally indices of the turkey population.

Legislative Committee: Don Heckman gave a verbal report.

Don got onto Federation of Sportsman's Clubs website for game bills that are being tracked and firearms bills that are being tracked under legislation. There are 46 game bills and 46 firearms bills.

The ones that we need to be looking at right now, although we have discussed the first one HB13 – Landowner Liability.

- **HB13** Landowner Liability. Please contact your State Senator ASAP and ask that they support this bill as written, no amendments.
- **SB580** Turkey Dogs Passed the senate now in the House.
- **HB863** Legislation that would move spring gobbler season length from noon to 5:00 p.m.

The Board agrees to not support legislation setting seasons and bags limits. That it is strictly a Pennsylvania Game Commission title 58 regulation.

There are 46 bills out there and 35 are anti-gun, anti-NRA, anti-second amendment, and anti-protection. That is what we are dealing with and Philadelphia has the power to move those bills.

The 2 firearms bills that we are watching and pushing are:

- **HB641** Castle Doctrine : Self-protection outside of your house. Pro-gun, proprotection, and pro-second amendment rights.
- **HB1292** Concealed Carry in State Parks. You would still have to have your concealed permit. As of right now you cannot carry concealed in State Parks.

**HB641:** The Castle Doctrine (this bill is pro gun) – We tried to get this bill passed last year and it died. This is with a Republican House and Senate. This bill has again been introduced in the House, which are Democrats, which further defines self-defense. This bill will be going to the Judiciary Committee and if it comes out of committee we will let everyone know so we can start tracking it.

Tried to get it into the last Turkey Talk, at which time Walt Young stated he didn't understand the information and didn't feel the average reader would understand it either. No matter what we do, we definitely need to make sure there is cover letter explaining this report card.

We will work on this chart and try to make is more user friendly and present it at the Chapter President's meeting to get feedback from the members. After that meeting, we will then take the suggestions back and put them into the report card and hopefully have it ready to go into PA Turkey Talk by the September 1 deadline.

**SB580 – Turkey Dogs –** We discussed the status of the bill and what the PA State Chapter Board will support in our motion. The Senate approved said bill, SB580, as written, no amendments, 49 to 1, so it now has moved over to the House and has been assigned to the House Game and Fisheries Committee. The House Game and Fisheries Committee will hold a public meeting on Wednesday, June 6, 2007 and that is a topic.

This is one of the bills that they will address. They will either report out of the committee or they will keep it in the committee from that public meeting.

Don found out within the last couple of weeks that the way SB580 is written, this bill does not allow the PGC to look at any kind of possible regulation, whatever that might mean under Title 58. Don was unsure if someone would introduce an amendment at the public meeting to change the wording, they would certainly have that option. That is the status at this time.

The bottom line, as Don believes it, would be that if that bill would get reported out of committee, goes to the full House for a vote and if they vote in favor of the bill without any amendments it will then go to the Governor's desk and he will be asked to sign that bill. If he signs that bill under Title 34 it changes the Game Law Code. There is nothing in that bill to allow the PGC to look at Title 58 – Regulation.

Which means that any dog, sporting, non-sporting, hunting, non-hunting, would be legal for anyone hunting fall turkey.

**Hunting License Increase:** There is no support for this increase in the House or Senate, however, the Senate seems to be our best avenue to a hunting license bill prepared and have it introduced. The Pennsylvania Sportsman Coalition, along with Joe Neville, are trying to figure out the ways and means of getting something introduced this fall. Budget is top priority along with a few other bills they are working on until the end of June. July and August is their recess, they will come back in mid to late September, that will be the time to find a Senator to ask for a hunting license increase to be introduced.

**Turkey Hunting License:** As part of that hunting license increase, again we come back to that table with a turkey hunting license as part of the package. Again we are going to ask for the Coalition and the Legislators to support a \$5.00 resident and \$20.00 non-resident turkey hunting license to be included in the hunting license increase package when it gets written as a bill.

Alternate Funding: Several other avenues that are being explored right now, alternative funding being one of them. Possibility we are looking at a figure of \$15 million. Breakdown would possibly be \$10 million for PGC, \$5 million for Fish and Boat, as alternative funding from the Pennsylvania State Sales Tax. We are looking at approximately 1/16 of 1% of the state sales tax. We know that the sales tax funds of 6% that we use today is already allocated. We also know that the budgetary process is looking at raising the PA Sales Tax to 7% which is a 1% increase possibly. Possibly under that 1% increase we have a Financial Chairman of the House that would be willing to go to bat for us, David Lavansky.

Possibly there is a chance they will consider a line item in that budget. Possibility that something might be accomplished through alternate funding. Question that is going around the Sportsmen's Coalition Organizations that are asking for alternative funding

considerations and the boards, not necessarily the membership, is "Are you all (the boards) supporting game and fish revenue coming from other sources besides what both organizations say. They receive no state tax money". That is a huge statement. That is a huge mountain to climb. Maybe it is time that the PGC look at alternative funding seriously. Alternative funding meaning money being used out of that sales tax. We will hopefully have more information by the August meeting.

## New Business

PA Sportsman's Coalitions request to sign on to a letter authorized by the PA Sportsman's Coalition, which is now 14 conservation and environmental organizations for the Whitetail Deer Audit - Don sent this letter around to the Executive Board Committee and the Executive Committee signed off on this as Don was under a fairly restricted time line because we had to have that letter done on Tuesday so they could take it to a House Game and Fisheries Committee Meeting on Wednesday. The deer audit letter is a letter that requests the legislators to not pass any deer management regulations in a legislative bill. It is a way to ask the legislators to get past this deer management hang-up concept they are under and allow the PGC to create a deer management presentation to be given to the deer hunters of Pennsylvania. It is called a Deer Management Audit and it is to work with the legislators to help them get by this impasse they are having for the hunting license increase.

The Sportsman's Coalition offered a letter to the Executive Committee were we made a few changes, sent it around for approval to the Executive Committee. Don then sent the letter on to the appropriate people. The next day this letter was in front of every House Representative, every Senator, and the Governor's office. Is this letter going to work, probably not, however through this letter we are on record, as hunters and trappers, as supporting wildlife management, supporting habitat and land management, as being sound scientific wildlife management based.

**PGC Commissioner:** Jay Delany from District 7 is the new appointed PGC Commissioner and he will be seated at the June 25 - 26 Game Commission meeting.

This Game Commission Meeting will be a first ever event in the 112 year history of the PGC for a trial of a disposed Game Commission President.

**Ned Smith Center:** Don Heckman brought to the board about paying our membership to the Ned Smith Center.

Motion made by Don Heckman that the PA Chapter of NWTF join the Ned Smith Center of Nature and Art for a 1 year subscription in the amount of \$50.00, which would be a sustaining membership. Don' O'Brien seconded the motion. Motion carried. **Jerry Zimmerman Habitat Project:** Don walked up to the Jerry Zimmerman Habitat Project. The Jerry Zimmerman Memorial Sign is there at the food plot. The plot is a little dry – we need some rain. But the sign is in place.

**Telling the Story:** We still are having a problem communicating to turkey hunters. We have done one-half of a news release since September 1, 2006. The PA NWTF has done a lot of things this year.

#### There are 3 ways of getting our story out:

- News Releases
- Turkey Talk Articles
- One on One

What can we do as a Board to correct the mistakes of the past in this organization so that we can communicate better to turkey hunters and the general public, through a better mechanism of news releases, articles, and communication for turkey hunters?

We need to get people to write these articles and get them to Bob Kasen, who can then get them to the outdoor writers. We need to get the Chapter President's on board with this also. Bob Kasen has the avenue to get these news releases out to the outdoor writers.

Joe Drolet will be sending the Chapter President's email addresses out to Bob Kasen to be used to send out news releases.

**Dart Systems:** Should we have one of the dart system units at the President's Meeting in August so we can show how it is set-up to anyone who is interested? We could possibly do it during the trap shoot on Saturday evening. We will have a system at the event.

- Larry stated that on May 5, he got a phone call from Audrey Zimmerman. That morning Audrey had her granddaughter, Colleen, out turkey hunting at Jerry's old camp. Audrey called a longbeard in and Colleen shot it at 21 steps. Audrey will be writing an article in the PA Tukey Talk.
